**SUBMISSION OF IDEAS TO SOURCE PLUS, INC.**

To avoid any possible future confusion between your ideas and those already in the public domain or in the possession of Source Plus, and to prevent any misunderstanding as to your rights and the obligations of Source Plus, your submission can be considered only under the following terms:

1. Source Plus does not solicit idea submissions or suggestions and sending this form does not constitute an invitation to disclose an idea.
2. No idea will be considered unless it is submitted in writing. Material submitted will not be returned, so retain a copy for your file.
3. Source Plus cannot agree to hold your new idea in confidence because it may be helpful to disclose the idea to others for evaluation, and because agreements to hold in confidence have been found to entail other obligations which Source Plus cannot accept. It is understood, therefore, that no confidential relationship is entered into by reason of the fact that Source Plus is considering your submission.
4. Any submission is made on the understanding that Source Plus shall give it consideration as it merits in the sole judgment of Source Plus. Source Plus assumes no obligation to evaluate or pursue the idea, and is under no obligation to reveal to you any information. Also, Source Plus has no obligation to return the submitted materials to you.
5. Source Plus will consider your idea submission only at your request, and then only with your assurance that, to the best of your knowledge, you are the sole originator of the idea, that you own it and that you have the legal right to negotiate with Source Plus concerning it.
6. It is agreed that in protecting your idea you shall rely solely on your rights under the patent, trademark, and copyright laws, and that consideration of your submission by Source Plus shall in no way impair Source Plus' right to contest the validity of your patent, trademark or copyright.
7. The consideration or review of your idea shall imply no agreement for compensation. Should Source Plus decide, after due consideration, that your idea is novel and previously unavailable to the public or state of the art and of use to it, the extent of your compensation will be determined by a written agreement between yourself and Source Plus. Negotiations, or offering to purchase an idea, shall be without prejudice to Source Plus and will not be an admission of the novelty, priority, or originality of the idea.
